Medical College, Belgaum for purpose of recognition of M.D.(Community Medicine) and D.P.H. qualifications granted by Karnatak University. The Council approved the following recommendations of the P.C. Committee which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Committee considered the Council Inspector's report (March, 98) and decided to recommend that M.D.(Community Medicine) and D.P.H. qualifications granted by Karnatak University in respect of students being trained at J.N. Medical College, Belgaum be recognised and included in the First Schedule to the I.M.C. Act, 1956 restricting the number of admission to 4 (four) students in each course per year.

The Committee further decided to advise the college authorities to comply with the observations as made in the inspection report."


