

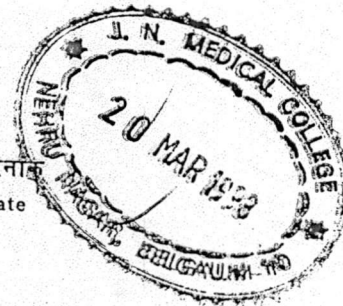

Sir,

I am to state that the minutes of the Postgraduate Committee meeting held on 6th Jan., 1993 containing recommendations for recognition of various qualifications granted by respective University including the recognition of M.D. (Pathology) qualification granted by Karnatak University in respect of students being trained at J.L.N. Medical College, Belgaum included in the above minutes vide item No.15 were duly placed before the Council at its meeting held on 6th Feb., 1993 for approval. The Council noted the following recommendations of the Postgraduate Committee which I am directed to forward herewith for necessary action in the matter:-

"The Postgraduate Committee recommends that M.D. (Path.) degree qualification granted by Karnatak University in respect of students being trained at J.L.N. Medical College, Belgaum be recognised and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Committee further recommends that J.L.N. Medical College, Belgaum be approved for the award of D.C.P. qualification granted by Karnatak University".


