I am directed to inform that combined assessment of the physical and the other teaching facilities available for increase of seats as well as continuance of recognition of MBBS degree granted by KLE University's Jawaharlal Nehru Medical-college, Belgaum (Previously affiliated to Rajiv Gandhi University of Health Sciences, Bangalore) in respect of students being trained at Jawaharlal Nehru Medical college, Belgaum was carried out by the Council Assessors on 2nd & 3rd April, 2013. The said assessment report was considered by the Board of Governors at its meeting held on 29.04.2013. The decision of the Board of Governors was communicated to you vide letter dated

On receipt of the compliance, the matter was considered by the Board of Governors on 25.06.2013 and it was decided to approve the renewal of permission for admission of 3rd batch of MBBS students against the increased intake i.e. from 150 to 200 for the academic year 2013-14.

The matter with regard to continuance of recognition for 150 seats has been reviewed by the Board of Governors on 23.10.2013 and it has been decided to approve for continuance of recognition of MBBS degree granted by the KLE University's Jawaharlal Nehru Medical collège, Belgaum (Previously attiliated to Rajiv Gandhi University of Health Sciences, Bangalore) in respect of students being trained at Jawaharial Nehru Medical college, Belgaum restricting the number of admissions to 150 (One Hundred and Fifty) students per year.

It is turther to inform you that your institution is fully responsible to fulfill and maintain norms including the intrastructure both physical and human resource, teaching faculty and clinical material etc. throughout, as stipulated in Regulation of Medical Council of India.
