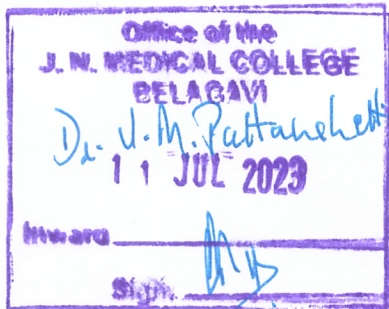
Sir,

In continuation to UGMEB's letter dated 18.05.2023 on the subject cited above, I am directed to say that your appeal filed before the Appeal Committee under the Chairmanship of Chairman, National Medical Commission was heard on 08.06.2023.

2. After hearing the submission made by the college authorities and verification of the facts, the Committee granted Continuation of Recognition of 200 MBBS degree seats for five (05) years. Copy of the order dated 23.06.2023 is attached herewith.

3. In view of the above, the Continuation of Recognition is granted of MBBS degree when awarded on or after February, 2023 by KLE Academy of Higher Education & Research (Deemed), Belagavi in respect of the students being trained at Jawaharlal Nehru Medical College, Belagavi, Karnataka with an annual intake of 200 MBBS students under the following terms & conditions, as contained in the Gazette Notification No.MCI-34(41)/2010-Med./3491, dated 16th April, 2010 titled " Establishment of Medical College Regulations. (Amendment), 2010 :

- (i) The recognition so being granted herein, shall be valid for a maximum period of 05 (five) years from the date of issue, upon which it shall have to be renewed.
- (ii) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.
- (iii) Failure to seek timely renewal of recognition as required in sub-clause(i) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute.
