CIRCULAR

Sub: Implementation of Passing criteria for University Examinations of MBBS CBME batches & Award of Grace marks for MBBS CBME batch students as per recent NMC guidelines.

With reference to subject cited above, as per the discussion in the Board of Examination and Academic Council of KAHER meetings held on 15th Nov 2023 & 24th Nov 2023 respectively, the competent authority of KAHER has approved to implement the New Passing Criteria as given by NMC (Ref.no. U/14021/8/2023 UGMEB dated 1st September 2023) for all the University Examinations of MBBS course (CBME batch 2019 and onwards across all the Phases) conducted after 1st September 2023 as below.

Criteria for passing in a subject;

- i) The aggregate or sum-total of Theory and Practicals for a given subject shall be atleast 50% to declare a student as having successfully cleared a subject, ie, passed in a subject. However,
- ii) The minimum score in Theory Examination shall be atleast 40% of the allotted marks.

 In subjects that have two theory papers, the leaner must secure minimum of 40% of marks in aggregate (both papers together).
- iii) Minimum score in practicals shallbe 40% of the allotted marks.

Further with respect to NMC Notification dated 1st August 2023, it was also approved to implement.

iv) "No Grace Marks" for passing the University Examinations of MBBS course (CBME batch 2019 and onward across all phases) conducted after 1st September 2023.
